

# 2025 GOLF EVENT PRICING

### TEE TIME GOLF EVENTS

\$60 PER PLAYER

Minimum 60 players, must pay for all reserved tee times.

### SHOTGUN GOLF EVENTS

\$60 PER PLAYER

#### APRIL - OCTOBER

Weekday \$8,500 (plus tax)
Weekend \$10,000 (plus tax)
Holiday\* \$8,500 (plus tax)

### SCORING PACKAGE

All outings include Golf Genius live cart and app scoring, outdoor electronic leaderboard, calculation of scoring/skins/contests/tie breakers, and event portal access. Up to six sponsors may be uploaded to the golf carts for the day.

All players must ride. Should additional carts be required, carts will be procured by A.J. Jolly for an additional fee. Maximum of 33 groups during event unless requested. Notification of cart requirements should be received a minimum of 30 days prior to the event. NON-player carts can be rented at the 18-Hole with cart fee of \$25.

Payment for the event must be made within seven (7) days of the event. Accepted tender methods include Cash, Check, American Express, MasterCard, Visa, and Discover.

To maximize the success of your event, A.J. Jolly must receive complete information consisting of each golfer's name and pairings (if applicable) at least 48 hours prior to the event. The Professional Staff will create customized cart signs, scorecards, and a tournament scoreboard if all information is provided within this timeframe.

#### **FOOD AND BEVERAGE:**

A guaranteed food and beverage count is required seven (7) business days in advance of the event. A.J. Jolly supplies tables and chairs for up to 150 guests. Any items rented or purchased on behalf of the event, such as additional tables and chairs, will be procured at an additional charge.

#### **INCLEMENT WEATHER:**

Rain, cold, or generally poor weather conditions are not grounds for cancellation. If the course is open, you are expected to play. In the event of rain and or inclement weather, play will continue unless the golf course is closed due to unplayable conditions as determined by A.J. Jolly Maintenance Staff. If play is unable to resume due to the continued threat of lighting or closing of the course and every player has completed at least nine (9) holes, the event will be deemed completed as a 9-hole event and every player will receive a 9-hole rain check. If less than nine (9) holes are completed by any player, all players in the event will receive a rain check for 18 holes to be used within one year of issue date.

Any unusual damage to the course, golf carts, or other areas of the facility are the responsibility of the outing coordinator and sponsors.

#### **OTHER GUIDELINES:**

(A) In connection with the golf event described above, the sponsor HEREBY RELEASES, DISCHARGES, AND COVENANTS NOT TO SUE all persons, agencies, parties, or organizations associated with the Campbell County Fiscal Court, and/or A.J. Jolly Golf Course, including but not limited to their administrators, directors, agents, officers, members, volunteers, and employees, other participants, as well as any sponsors and advertisers along with any of their affiliates, agents, representatives, assigns, successors, officers, directors, shareholders, and employers, and if



applicable, owners and lessors of premises on which the ACTIVITY takes place, including, but not limited to, A.J. Jolly Golf Course or Campbell County Fiscal Court and any affiliates or subsidiaries of such entities, any successors and assigns of such entities, and any officers, directors, shareholders, agents, and/or employees of/or associated with such entities (each considered one of the "RELEASED PARTIES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, INJURIES, DAMAGE TO PROPERTY, OR OTHER DAMAGES ON MY/OUR ACCOUNT OR THE MINOR PARTICIPANT(S) ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASED PARTIES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf or on the minor participant's behalf, makes a claim against any of the "RELEASED PARTIES", I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE "RELEASED PARTIES" from any litigation expenses, attorneys' fees, loss, liability, damage, or cost which any may incur as the result of such claim.

(B) Promotion, engagement, or facilitation of illegal activities on A.J. Jolly Golf Course property is prohibited.

A.J. Jolly Golf Course is not responsible for the damages or loss of any item left on property prior to or following any event. Your event must receive approval before storing items at the course. All items and materials must be removed from the course before 8:00 AM the day following the event. A.J. Jolly is not responsible for the security of these items.
